#### Land Acknowledgement \_

In the spirit and intent of the Truth and Reconciliation Commission's recommendations, Nightwood Theatre acknowledges the land on which our work is created and where our offices are located is the traditional territory of many Nations, including the Mississaugas of the Credit, the Anishnabeg, the Chippewa, the Haudenosaunee, and the Wendat peoples, and is home to many diverse First Nations, Inuit, and Métis peoples.

We acknowledge them and any other Nations who care for the land (acknowledged and unacknowledged, recorded and unrecorded) as the past, present, and future caretakers of this land, the traditional territory named Tkarón:to, the Mohawk word for "the place in the water where the trees are standing." The treaty for this particular parcel of land (Treaty 13), collectively referred to as the Toronto Purchase, applies to lands east of Brown's Line to Woodbine Avenue and north towards Newmarket.

We recognize the enduring presence of Indigenous peoples on this land. We commit ourselves to addressing and disrupting the systems of oppression and the colonial forces that undermine, distort, or erase the vital role of Indigenous peoples in our world, and recognize stewardship as a shared responsibility of all those who reside in a territory, as is the spirit of the Dish With One Spoon Wampum agreements.

The Lawyer Show is the main annual fundraiser for Nightwood Theatre, a registered charitable organization and Canada's flagship feminist theatre since 1979. Every year, over 35 members of the legal community rehearse for three months to mount an exhilarating, entertaining, professionally led musical. Since the Lawyer Show's inception in 2010, some 300 legal professionals have appeared in 11 different productions to raise more than \$1,265,000 in support of Nightwood.

When our anticipated Lawyer Show production of Joseph and the Amazing Technicolor Dreamcoat was cancelled due to the pandemic in March 2020, we never dreamed that we would still be unable to gather together on stage over a year later. Thanks to the endless efforts of our hardworking cast, band and creative team over many months of remote rehearsals and recordings, we are deeply honoured to have been able to produce the Lawyer Show's very first professional audio recording of The Stars of Mars. This Toronto-born musical was written by two brilliant local artists and developed for Sheridan College's Canadian Music Theatre Project – just like another musical you may have heard of, Come From Away!



#### Message from the Director \_

### Welcome to the 2021 Lawyer Show - We are so thrilled to finally share *The Stars of Mars!*

Rehearsing a show always demands huge commitment and energy, as well as a willingness to give over to adventure. The experience of creating a full show entirely remotely was a brand new experience for Nightwood despite our numerous decades of professional theatre experience. Working exclusively online required us all to embrace new ways of sharing space—warm-ups where no one is making silly sounds beside you, competing with different internet speeds while trying to sync voices and accompaniment, and the challenge of not having that friend in rehearsal who somehow always knows the right notes and helps you stay in key by proximity. But what we lost in familiarity, we gained in innovation, in adaptability, and in working together as a team, earning our resiliency badges if we hadn't already over the last 15 months.

We were thrilled to stumble upon the new musical *The Stars of Mars*. We loved that it was a fresh original work that offered a light and tender story with contemporary social underpinnings and a lot of humour. We were able to support exceptional local musical theatre duo Ashley Botting and Daniel Abrahamson in a time of drought in our industry, offering sustenance for them and for their play as it further develops through the voices of these lawyers. The piece, which takes place largely in a habitat on Mars, has uncanny resonances with the challenging, often isolating times we are living in.

We wouldn't have made it to the finish line without a devoted group of professional theatre artists leading the way including: Sedina Fiati - the show's unstoppable Assistant Director who leapt in on every front and instantly fell in love with the cast; Paul Moody - who truly, tirelessly and passionately shepherded this project as Musical Director; Emily Porter - who not only mixed the thousands of sound files but also designed a vivid audio-world on Mars; Production Facilitator Hazel Moore -

who stepped bravely into her first professional gig coordinating an entire show on Zoom; and designer Michelle Tracey - who created stunning designs that instantly embraced the style and concept for this show (that had to go on)! I'd be remiss if I didn't shout out Ashley Botting and Daniel Abrahamson, the creators of this beautiful and hilarious musical,

as well as Stream Stage run by Daniel Abrahamson for their support with video editing, their bespoke VR world, and for streaming the show. And huge thanks to the Lawyer Show Committee and the incredible staff at Nightwood who have put so much energy and brilliance into making this show happen.

This production of *The Stars of Mars* has entirely been recorded from the homes of our incredible cast members and band. Throughout the winter and spring these 40+ lawyers

- most of whom have faced their busiest years yet, working under extremely challenging conditions at home with zero childcare - lent themselves to this cause and this project so wholeheartedly, with the blessings of their firms, spouses, babies, neighbours, dogs and cats, while they learned an entire two act show full of very challenging songs, harmonies, and dialogue. Recognizing that half of the joy of a project like this is in being together, we were so touched at the outpouring of enthusiasm to come back again this year. Their generosity, grit and immense talent has astounded us.




#### John McGowan -Bass Guitar/Keyboard 2
